



BALLOT TITLE

PROPOSAL TO ANNEX CITY OF CLATSKANIE TO RAINIER CEMETERY DISTRICT

QUESTION: Shall the City of Clatskanie annex to the Rainier Cemetery District for the purpose of receiving cemetery services?

SUMMARY: Approving this measure would annex the properties within the City of Clatskanie as its boundaries now exist to the Rainier Cemetery District. The Clatskanie City Council proposed this measure annexing the properties within the City to the Cemetery District. Annexation would allow the Rainier Cemetery District to provide cemetery services directly to properties within the City, which would subject properties within the City to the Rainier Cemetery District's property tax rate, and allow residents within the City to vote on the membership of the Cemetery District's governing board, beginning with the May, 2013 election. The Rainier Cemetery District's current property tax rate is .0709 dollars per thousand dollars of assessed value. This measure requires approval of both Cemetery District and City of Clatskanie voters.

EXPLANATORY STATEMENT

The City of Clatskanie and the Rainier Cemetery District have proposed a mutual annexation for the voters' approval. This annexation expands the Cemetery District to include the three cemeteries within the City of Clatskanie. If passed, this annexation would change ownership of the three cemeteries from the City to the District where the District would take over the maintenance and administration. This annexation requires the approval of both the citizens within the Clatskanie city limits and within the Cemetery District boundaries.

The property owners in Clatskanie would see a small property tax added to their statements. This tax equates to .0709 per thousand. If your house is valued at \$100,000, the tax is seven dollars (\$7) a year. Literally, 2 cents per day.

The advantage for Clatskanie is the City would turn over operations of the cemeteries to an entity that is in the cemetery business. The City's Cemetery Fund has been unable to cover the cost of maintenance for the past several years. The City's Cemetery Fund is operated as an "Irreducible Fund" as mandated by the State. The concept of the "Irreducible Fund" has been to operate the cemeteries with the interest generated by the fund. The fund currently has a balance of about \$165,000. The current interest rate is one half of a percent (.5%). This means that the City is expected to cover all costs with interest earnings of \$1,000 per year. The current annual operating budget is \$16,000. This does not include the cost of grave materials or the City public works crew. As a result of the shortfall, the City covers the fund with monies from other funds. This has reduced the amount of money available to provide other services (water, sewer, street repair, and police) for the citizens of Clatskanie. By annexing into the District, a broader citizen base will fund the maintenance and administration of the cemeteries.

The benefit for the Rainier Cemetery District is they also get a larger support base that would allow them to hire additional help to maintain their existing cemeteries as well as the three in Clatskanie. They would also receive the balance of Clatskanie's Irreducible Fund and, because they are a specific cemetery district, and not an Irreducible Fund entity, they are able to use this fund for cemetery purposes (example: Clatskanie's Murray Hill Cemetery needs another columbarium). The Rainier Cemetery District also wants to increase the size of its board from three members to five. The increase in board size would allow citizens of Clatskanie the opportunity to serve on that board.

BALLOT TITLE

REQUEST TO ANNEX CHURCH PROPERTY INTO THE CITY OF ST. HELENS

QUESTION: Should land located at 35031 Millard Road be annexed into the City of St. Helens?

SUMMARY: On April 14, 2010, Juanita Richards for the St. Helens Bible Church applied to the City of St. Helens for annexation of approximately 3.02 acres of land located at 35031 Millard Road. This property is also described as Columbia County Map & Tax Lot Number 4N1W-8CB-501. The City Planning Commission recommended to the City Council that the property be annexed and that the property have a Comprehensive Plan designation of Suburban Residential, SR, and be zoned Moderate Residential, R-7. The City Council approved the recommendation on October 20, 2010. On December 7, 2011, the City Council adopted Ordinance No. 3154, which would officially approve the annexation and zone the property R-7, Moderate Residential, contingent upon the voters approving the annexation as required by the City Charter, Chapter 1, Section 3. Approval of this request will make the property subject to all City ordinances and regulations.

EXPLANATORY STATEMENT

The **St. Helens Community Bible Church** applied to the City of St. Helens for annexation of approximately 3.02 acres of land located at 35031 Millard Road. Annexation is the process whereby property is included or brought into the city limits. The City has a process for evaluating annexation requests that includes conformance with applicable State laws, the City Charter, City Comprehensive Plan, and City Development Code. The process requires that the City Planning Commission hold a public hearing on annexation requests and make a recommendation to the City Council. The City Council also holds a public hearing and reviews the recommendation of the Planning Commission. If the City Council approves the annexation request, then the City Charter requires that a majority vote of the voters of St. Helens approve the annexation.

For the St. Helens Community Bible Church annexation request, the Planning Commission held a public hearing, found that the request complied with the process for annexation, and recommended approval of the annexation request to the City Council. The City Council approved the recommendation to annex the St. Helens Community Bible Church property, which is approximately 3.02 acres in size, on December 7, 2011. The next step is for the voters of St. Helens to approve or reject the request to annex this property. If annexed, the property will be zoned R-7, Moderate Residential, and be subject to all City ordinances and regulations.

REQUEST TO ANNEX PORT PROPERTY INTO THE CITY OF ST. HELENS

QUESTION: Should land located at 58144 Old Portland Road be annexed into the City of St. Helens?

SUMMARY: On May 6, 2011, the Port of St. Helens applied to the City of St. Helens for annexation of approximately 145.3 acres of land located at 58144 Old Portland Road. This property is also described as Columbia County Map & Tax Lot Number 4N1W-17-100. The City Planning Commission recommended to the City Council that the property be annexed and that the property have a Comprehensive Plan designation of Heavy Industrial, HI, and be zoned Heavy Industrial, HI. The City Council approved the recommendation on January 4, 2012. On February 1, 2012, the City Council adopted Ordinance No. 3156, which would officially approve the annexation and zone the property HI, Heavy Industrial, contingent upon the voters approving the annexation as required by the City Charter, Chapter 1, Section 3. Approval of this request will make the property subject to all City ordinances and regulations.

The **Port of St. Helens** applied to the City of St. Helens for annexation of approximately 145.3 acres of land located at 58144 Old Portland Road. Annexation is the process whereby property is included or brought into the city limits. The City has a process for evaluating annexation requests that includes conformance with applicable State laws, the City Charter, City Comprehensive Plan, and City Development Code. The process requires that the City Planning Commission hold a public hearing on annexation requests and make a recommendation to the City Council. The City Council also holds a public hearing and reviews the recommendation of the Planning Commission. If the City Council approves the annexation request, then the City Charter requires that a majority vote of the voters of St. Helens approve the annexation.

For the Port of St. Helens annexation request, the Planning Commission held a public hearing, found that the request complied with the process for annexation, and recommended approval of the annexation request to the City Council. The City Council approved the recommendation to annex the Port of St. Helens property, which is approximately 145.3 acres in size, on February 1, 2012. The next step is for the voters of St. Helens to approve or reject the request to annex this property. If annexed, the property will be zoned HI, Heavy Industrial, and be subject to all City ordinances and regulations.

BALLOT TITLE

PROPOSAL TO ANNEX CITY OF CLATSKANIE TO RAINIER CEMETERY DISTRICT

QUESTION: Shall the Rainier Cemetery District annex the City of Clatskanie and provide cemetery services within the City of Clatskanie?

SUMMARY: Approving this measure would annex the properties within the City of Clatskanie as its boundaries now exist to the Rainier Cemetery District. The Clatskanie City Council proposed this measure annexing the properties within the City to the Cemetery District. Annexation would allow the Rainier Cemetery District to provide cemetery services directly to properties within the City which would subject properties within the City to the Rainier Cemetery District's property tax rate, and allow residents within the City to vote on the membership of the Cemetery District's governing board, beginning with the May, 2013 election. This measure requires approval of both Cemetery District and City of Clatskanie voters.

EXPLANATORY STATEMENT


The Rainier Cemetery District and the City of Clatskanie have proposed a mutual annexation for the voters to approve. The annexation expands the Rainier Cemetery District to include the three cemeteries within Clatskanie. The annexation changes ownership of the three cemeteries from the City to the District where the District would take over the maintenance and administration of Clatskanie's cemeteries. This annexation requires the approval of both the citizens within the Clatskanie city limits, and within the Cemetery District boundaries. The vote by the existing citizens of the Rainier Cemetery District is only a vote to approve the annexation. There is no change to the Rainier Cemetery District's tax rate. The annexation of Clatskanie to the District expands its tax base to include the property within Clatskanie. This expanded tax base would allow the district to hire additional help and provide extra resources to manage the cemeteries under its care. The other positive for the district is the city of Clatskanie will turn over to the District the balance of their cemetery fund, approximately \$165,000. The city used this fund to pay for maintenance and materials and had to operate the fund as an "Irreducible Fund" which means the interest generated off of the fund principle is supposed to pay for cemetery maintenance. This created a hardship for the city when interest rates dropped to one half of 1 percent (.5%). That meant the city had to operate the cemeteries with only \$1,000 of interest income. This nowhere near covered the \$16,000 annual maintenance budget. The city began discussions with the Cemetery District earlier this year and both parties agreed that having Clatskanie join the Cemetery District was a benefit for both entities. The city would get a professional Cemetery District to maintain and operate its 3 cemeteries saving the city money and the Rainier District would gain a larger tax base allowing additional resources into the district. One of the other results of this merger will be the Cemetery District intends to increase the size of their board from three members to five.



