All candidates on the ballot have had the opportunity to submit paid Candidate Statements in which they can describe the reasons you should cast your vote for them. Any "Ballot Titles" and "Explanatory Statements" were written by the governing body submitting the question.

We will be open on Friday, May 16<sup>th</sup> from 8:30 am until 12:00 and Saturday, May 17<sup>th</sup> from 10:00 am to 2:00 pm to issue ballots, receive ballots and answer any questions a voter may have.

We hope that you will take the time to become informed on the candidates and issues and exercise your right to vote in this important election.

#### **BALLOT TITLE**

THREE-YEAR LOCAL OPTION LEVY FOR JAIL OPERATIONS

QUESTION: Shall Columbia County levy \$0.5797/\$1000.00 of assessed value for three years beginning in 2014-2015 for jall operations? This measure may cause property taxes to increase more than three percent.

SUMMARY: In 1998, County voters approved construction of a new jail with a 255 bed capacity without corresponding operating funds. The County General Fund and bed rentals have supported Jail operations for 13 years.

The cost to supervise, feed, clothe and provide health care for a larger inmate population is now known to be substantially more than the costs to run the old Jail, has increased each year, and is a major expense in the jail budget.

The County General Fund has experienced a significant decrease in the last several years and can no longer sufficiently support jail operations. This decrease has led to reducing bed capacity to 25 local inmates, which is down from 65 last year. The continued operation of the Jail in any capacity is dependent upon Federal bed rentals.

The proposed levy would restore 75 beds, for a total of 100 local beds, fund six additional corrections deputies and one supervisory position, and provide constitutionally required food, clothing, management and health care to inmates.

The estimated money raised will be \$2,287,572 in FY 2015, \$2,356,199 in FY 2016 and \$2,426,885 in FY 2017, for an estimated total levy of \$7,070,656.

#### **FXPLANATORY STATEMENT**

If passed, the jall operating levy will provide funding to continue operation of the County Jail. If the measure does not pass the County Jail will close by June 30, 2014. The proposed levy would be for a maximum of .5797 cents per thousand. A property owner with assessed value of \$100,000 would pay \$57.97 per year for three years.

The operating funds will be used to hire corrections deputies and one supervisory employee to manage jail operations in a manner that is safe and secure for employees and inmates. The operating funds will also be used to provide constitutionally required care of inmates including food, clothing and health care. The use of operating funds will be overseen by a citizen oversight committee established by the County.

The County's old Courthouse jail was built in 1969 and was designed to hold a maximum of 39 prisoners. Because of overcrowding, inmates were often released before arraigment and sentenced prisoners were released before sentences were served. Conditions in the jail were substandard and the County was at risk of being sued.

In 1998. County voters approved a bond levy to build the current Jail, designed to house up to 255 inmates. While the cost to run the new larger jail was assumed to be substantially more than the cost to run the old Courthouse Jail, the County did not immediately request an operating levy for the new Jail. Rather, the County raised revenue by renting unfilled jail beds and increasing County general fund support. Currently, bed rental revenue makes up more than half of the revenue needed to run the Jail. However, the bed rental revenue is not dependable because the federal government will not guarantee it will rent any beds.

Available general fund support for the Jail has decreased in the last several years due to a decline in the County's second largest source of unrestricted funding; the O&C Forest payments, which dropped by 70% from \$2,000,000 in 2008 to \$600,000 in 2014 with no funding budgeted for 2015. Budgeted unrestricted general fund resources have decreased by one-third since 2005 from \$13.2 million to \$8.7 in 2014. The Jail has also experienced increased operating costs in personnel categories given health insurance premium increases and pension costs.

In 2011, due to the decrease in general fund support and increased personnel and operations costs at the Jail, the County reduced the maximum number of inmates to be housed at the Jail from 255 to 150, including 65 local beds. In 2013, due to the additional decrease in available general fund support and increased personnel and operations costs at the Jail, the County further reduced the maximum number of inmates to be housed at the Jail from 150 to 110, including 25 local beds. The County has laid off nine jail staff members since 2011. If passed, the County projects it will be able to again house 100 local inmates and hire sufficient staff to safely manage inmates.

## Measure No. 5-236

#### **BALLOT TITLE**

REVISIONS TO CITY OF COLUMBIA CITY HOME RULE CHARTER

QUESTION: Shall the voters of the City of Columbia City adopt revisions to update the City home rule charter?

SUMMARY: This measure would update the city charter of 1972 to remove obsolete provisions, clarify provisions, and reflect standard municipal organization and practices. The proposed revisions were developed by a citizen charter review committee and are based upon the League of Oregon Cities' model charter.

The Oregon Constitution gives City voters the right to revise a charter. The charter grants legal authority to the City and establishes duties and responsibilities.

The proposed revisions establish the position of city administrator as the administrative head of the City; require the municipal judge and city attorney be members in good standing of the Oregon State Bar; require the council to meet at least once monthly; require the establishment of council rules; require approval of ordinances by a majority of the council; prohibit the mayor and council from being employed by the City; require the council adopt nomination procedures to run for public office; prohibit council members from attempting to coerce the city administrator in matters concerning contracts, property, or the appointment or removal of employees; and set debt limits.

**EXPLANATORY STATEMENT** 

The Oregon Constitution gives City voters the right to adopt, amend and revise home rule charters. Columbia City voters adopted the current charter in 1972.

The Columbia City Council formed an impartial Charter Review Committee comprised of citizens of the City to evaluate the 1972 charter and to determine if the charter should be updated or changed. The Charter Review Committee determined that the charter should be updated to remove obsolete provisions, clarify provisions, and reflect standard municipal organization and practices. The Charter Review Committee utilized the League of Oregon Cities' model charter to develop the proposed revisions to the charter, and presented the proposed charter revisions to the City Council on April 4, 2013. The Council concurred with the recommendations of the Charter Committee, and referred this measure to the voters of the City of Columbia City for approval or rejection.

Of the proposed revisions to the Charter, the most significant will:

- Establish the position of city administrator as the administrative head of the government;
- Provide that the Council may remove the city administrator by majority vote with or without cause at any time;
- Provide a list of city administrator duties;
- Require that the municipal judge and city attorney be members in good standing of the Oregon State Bar;
- Require that the Council meet at least once monthly;
- Require the establishment of Council rules;
- Require approval of ordinances by a majority of the Council;
- Prohibit the Mayor and Council from being employed by the city;
- Require that the Council adopt nomination procedures to run for public office;
- Prohibit Council Members from attempting to coerce the city administrator in matters concerning city contracts, city property, or the appointment or removal of employees;
- Set debt limits.

# Measure No. 5-237

#### **BALLOT TITLE**

COLUMBIA RIVER FIRE AND RESCUE BOND FOR EQUIPMENT AND IMPROVEMENTS

QUESTION: Shall the District issue \$15,000,000 general obligation bonds to purchase equipment, finance station improvements and refinance an existing obligation? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11 b, Article XI of the Oregon Constitution.

SUMMARY: Passage of this measure provides funds to finance capital costs at District facilities. Specifically, this measure would:

- Acquire new and replacement fire apparatus, ambulances, rescue vehicles and other related equipment.
- Acquire safety equipment including self-contained breathing apparatus, protective clothing, radios and other safety equipment.
- Make station improvements, including seismic upgrades at the Rainier Station, expansion and seismic upgrades of the Fairgrounds station, had other station improvements.
- Refinance outstanding obligations of the District which financed the Lee Broadbent Training Center.
- Pay associated bond issuance costs.

Bonds would mature in twenty (20) years or less from issuance date and may be issued in one or more series.

EXPLANATORY STATEMENT

Columbia River Fire & Rescue (the "District") has proposed this measure for voters' approval. The Board of Directors has determined after Finance and Sustainability Committee recommendation and public meetings and surveys that it is in the best interest of the District to request long-term financing from the voters of the District. This measure would provide general obligation bond financing for the replacement of critical response equipment, station expansions and other safety-related capital expenditures.

The District is requesting general obligation bond authority up to \$15 million dollars to:

- Replace current apparatus as described in the District's apparatus replacement schedule at an estimated cost of \$7,000,000 over the next 15 years.
- Improvements to the Fairgrounds Fire Station including expansion for additional apparatus, personnel and community meeting space at an estimated cost of \$1,800,000. Planned 2021.
- Make seismic upgrades and other improvements to the Rainier Fire Station at an estimated cost of \$1,500,000. Planned 2021.
- Add a Fire Engine to the Deer Island Station to meet current Insurance Services Office (ISO) requirements at an estimated cost of \$450,000. Planned 2015.
- Replace communication hardware and other safety equipment as it reaches its end of life cycle, specifically:
  - Self-Contained Breathing Apparatus System. \$500,000. Planned Replacement—2023
  - Portable Radio equipment at an estimated cost of \$350,000. Planned Replacement—2020-2025
  - Other safety equipment as identified. Planned Replacement—2025

 Refinance the Full Faith & Credit Obligations (the "Obligations") utilized to build the Lee Broadbent Training Center in 2006. This is expected to provide a savings in interest payments to the District.


If approved, the District plans to issue bonds in no less than three issuances to coincide with the District's apparatus replacement schedule. Each issuance would be payable over 20 years with an estimated cost to the taxpayer of \$0.30/\$1000 assessed value or less per year. If your house is valued at \$100,000, the tax is expected to be \$30 per year.





