IV B</b></p>	<p><b>Issue:</b> A notice announcing a Request for Proposals was published in the Daily Journal of Commerce on October 15, 2014 and mailed to known HHW operations contractors on October 16, 2014(see attached). The complete Request For Proposals, contract terms and specifications were available to prospective proposers following the date of the initial notice.
