With nothing further coming before the Board, the meeting was adjourned.



Guidance on FYE 2017 Budget

- Next month Budget Committee Meeting
- Revenue forecasts do not need input
- Most expenditures do not need input
- However, do need decision on pre-payment of Road Loan versus ending fund balance

Guidance on FYE 2017 Budget

- Insufficient funds to pay off loan in 2017
- Every \$100,000 in extra payment saves \$5,000 in interest the following year
- Could make \$1.25M payment with zero ending fund balance
- Could make \$750,000 payment with \$500,000 ending fund balance
- Trade-off: \$25,000 in interest
